

## **LIST OF AMENDMENTS TO THE COMPANY'S ARTICLES OF ASSOCIATION**

### **The wording before the change:**

#### **§19**

1. Meetings of the Supervisory Board shall be convened by the Chairman of the Supervisory Board, on its own initiative or at the request of another member of the Supervisory Board or at the request of the Management Board, subject to section 2 below.
2. If the Chairman of the Supervisory Board fails to convene a meeting of the Supervisory Board at the request of the Management Board or another member of the Supervisory Board within 14 (fourteen) days from the date of receipt of the request, the applicant may convene the meeting independently, stating the date, place and proposed agenda.

### **Current wording:**

#### **§19**

1. Meetings of the Supervisory Board shall be convened by the Chairperson of the Supervisory Board, subject to section 2 of this paragraph.
2. The Management Board or a member of the Supervisory Board may request that a meeting of the Supervisory Board be convened, stating the proposed agenda. The Chairperson of the Supervisory Board shall convene a meeting with an agenda in accordance with the request, which shall be held no later than two weeks from the date of receipt of the request. If the Chairperson of the Supervisory Board fails to convene a meeting in accordance with the previous sentence, the person making the request may convene it independently.
